The knowledge test contains multiple choice and true false questions that show how well the person knows and understands Minnesota traffic laws and road signs. Only one test is allowed per day. Some stations offer a computerized test which is available in English or several other languages Hmong, Vietnamese, Somali, Spanish, and Russian. The person is tested on their ability to drive a motor vehicle safely under normal traffic conditions. The person may not have anyone in the car during the test other than the driver examiner. It is recommend that an appointment be scheduled for the skill test at a Driver Exam Station or at Schedule a Skills Test. This is not a medical exam, it is a screening to determine if their vision meets minimum standards. Peripheral vision must be at least 105 degrees in either one or both eyes. If the license has been expired for more than a one year, they will also then need to take a skills road test. This is true even if they have a valid drivers license from your former home country. A license from previous state of residence will be invalidated and returned to applicant. Licenses from another country are not invalidated as the person may use them if they have dual citizenship. If the person is unable to present current valid drivers license they will need to supply a certified copy of their driving record. Information about the license class and any endorsements or restrictions should appear on the back of the drivers license. The farm truck must be operated by the farmer, his or her immediate family member or an employee of the farmer. All endorsements require additional knowledge tests. Bus, school bus, and motorcycle endorsements require specialized road tests. A CDL allows a driver to drive all Class D vehicles, in addition to certain types of vehicles included in each drivers license class.

With a school bus and passenger endorsement, the holder may operate a school bus or bus designed to transport 16 or more passengers, including the driver. The license will carry specific restrictions. These requirements may apply to single unit and combination vehicles of more than 10,000 pounds gross vehicle weight such as construction vehicles, vehicles used to deliver packages and other items, and vehicles designed or used to transport more than eight passengers, including the driver. In order to legally operate these vehicles, a driver may need to possess a valid U. S. Department of Transportation medical examiners certificate. To check and see if you are listed on it there is a form you must complete and have your signature notarized, and then mail the completed form to the National Driver Register. Forms that are not notarized will not be processed by them. You then can find out if you are listed on the NDR. States will allow you to exchange an out of state license for a new license when you move to a state within the US, however the driver’s license you are turning in needs to be valid. I cannot speak Spanish and that I feel the major hurdle. Please help! Look on the map above to find the location closest to you. Go there and ask to speak to someone who speaks English. Just a thought, maybe this is the reason americans are hated all around the world. P.S. these words are coming from a american that learned the language. Still, if someone moves to PR on day 1, and needs a driver's license, they do not have time to have learned Spanish in such a short time period. Your suggestion that someone who moves here should stay in a hotel is terrible advice. Generally hotels are used for shortterm visitors, not residents. If one is just visiting, they are not going to need a PR driver's license. My point remains that there are excessive government employees, some of which could be used to translate the documents into English. Furthermore, making it easier to do business or accomplish tasks will save everyone time.

It remains true that it is far more difficult to get things done in PR compared to the states because of people who share your antiprogress type of mentality. This is a drag on productivity, GDP, and quality of life. Your resistance to progress is off base and such a bad attitude holds PR back. As long as you bring the correct identification documents and pay the fee, they should give you a Puerto Rican driver's license. Furthermore, I think you cannot yet get the Real ID version. They said that while it was in the news that a driver's license could be renewed online, the CESCO employee said in reality it CANNOT be done online, and must be done in person.
